


DOG DAYCARE AGREEMENT



1. The Kennel agrees that it will provide dog daycare services to the OWNER'S DOG(s) listed below in this Agreement during the term of this Agreement.

2. The PET(s) to be in daycare at the kennel for the term is/are named:

3. Information about each DOG is detailed in Addendum "A" to this agreem. Therefore Addendum for each DOG.

Term and Rate

- 4. The Kennel agrees to provide daycare services to COG (s) for _____ days, commencing on ______ at le daily rate of _____ / DOG.
- 5. In the event the PET'S stay at the KEYNEL is longer than the Term referred to in Clause 3, the OWNER agrees to pay additional tank Daycare Fees applicable.

Payment and Deposits

- 6. The OWNER agrees to pay the applicable daily Daycare Fees as specified. GST will be added to all Daycare Feet 1. Dayments will be made via cash, cheque, e-transfer, or online.
- 7. All Daycare Fees are prable in full upon delivery of the DOG (s) to the KENNEL.

Feed id Toys

8. If applicable, The OWNER will provide all of the DOG's usual food and treats along with feeding beta ctions for the term of the DOG's stay in daycare at the KENNEL.

Housing and Exercise

- 9. The DOG(s) will be kept solely on the KENNEL premises, either in the building, fenced offleash area, or on leash.
- 10. The DOG (s) will have complete access to water full-time, and will be fed as per OWNER'S instructions and feed / treats the OWNER has provided.

- 11. The DOG, if deemed suitable, will be in a supervised, open concept pack play with other dogs. If the DOG is not suitable for pack play, the DOG (s) will be penned separately in a large, individual run and exercised either in the fenced, off-leash area or on-leash walks at least twice a day.
- 12. The KENNEL recognizes the importance of personal, human attention for DOG (S) and ensures that each DOG will receive individual attention time that includes pets, cuddles, and play.

Health of Dog

- 13. The Owner represents that he or she is the owner of the DOG and that the DOG has not been knowingly exposed to distemper, rabies or any other infectious diseased parasites within the last 90 days. The Owner further represents that the DOG has received all, gaved vacciliations and that the Animal is in good health.
- 14. For each DOG in daycare, the OWNER will provide an original veterinarian's Certificate of Health that clearly states last date of immunizations and excirpt date of said immunizations. Each Certificate of Health must be issued and signed by a veterinarian that is licensed to practice veterinary medicine in the Animal's home province
- 15. Required vaccinations are Bordetella, Poies, ed DA2PP/DHLPP. Adenovirus is recommended.
- 16. The OWNER understands and agree what during nemal dog play, OWNER's dog(s) may sustain injuries. All dog play is fully so exised and carefully monitored by KENNEL staff to avoid injury; however, scratches, puncture, torn ligaments, etc. may occur despite the best supervision.
- 17. The OWNER represents that the D(G(s)) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any other person or any other dog.
- 18. The KENNEL reserves it in the refuse to provide daycare services to any DOG.
- 19. The KENNEL will do daily health check of the DOG (s) and record the information from this check. This information will be available to the OWNER upon request.



- 20. In the event a DOG becomes ill during their stay at the KENNEL, the KENNEL will make all reasonable efforts to immediately contact the OWNER or the Emergency Contact provided.
- 21. There are times when non-emergency medical attention may be necessary for various reasons such as unresolved intestinal distress, allergic reactions, injuries etc.
- 22. In an emergency situation, it may not be possible to communicate before treatment is needed. Our experienced staff will use their best judgement and seek veterinary care as necessary, which may be with the veterinarian listed below or the nearest available.

- 23. The OWNER authorizes the KENNEL to seek any veterinary care in the DOG's best interest and health up to and including euthanasia. Euthanasia will only be considered if absolutely necessary and approved by a veterinarian and in the DOG's best interest. Any cost incurred with be the OWNER's responsibility.

25. The OWNER understands and agrees the KENNEL staff are not licensed veterinarians and, therefore, will not attempt to diagnose animal ailments or discusses and the OWNER agrees the KENNEL will not be liable for any sickness or ailment the PEL develops or manifests during their stay at the KENNEL or the result of said sickness or ailment.

Unclaimed Animals

26. In the event an OWNER has not returned to the KENNEL to pick-up the PET within10 days after the scheduled pick-up date reference in Clause 3 and has not made any other arrangements for payment and/or continued boardin, of the DOG at the KENNEL, the KENNEL may, at its sole discretion, sell or otherwise place the DoG without notice to the Owner.

Liability

27. The OWNER understands and agrees the KENNEL will not be liable to the OWNER nor to any other party for any tartity, any consequential losses, any damages whether in contract, tort or otherwise, or any other class, expenses that may be connected with the services provided by the KENNEL included, but not limited to, loss or damage from disease, death, running away, theft, fire and injury to persons, other animals or property.

Indem

- 28. The OWE indemnifies the KENNEL, its agents and employees, from any loss, liability, claim or expense, resulting directly or indirectly from the OWNER's breach of any warranty or provision contained in this Agreement.
- **29.** The OWNER further indemnifies the KENNEL, its agents and employees, for any personal injury or damage to property caused or contributed to by the DOG.

General

- 30. The owner confirms that the DOG (s) has a valid city or municipality license, if required by said municipality.
- 31. All DOGs must be on-leash or crated when being dropped off and picked up.
- 32. The OWNER provides permission to KENNEL to take pictures or videos of DOG (s) and use them for the website, Facebook, or other marketing purposes.
- 33. Upon request, the above photos and videos can be provided to the Owner.
- 34. Any modifications to this Agreement must be in writing and signed by the darties or the modifications will have no effect and will be void.
- 35. This Agreement ensures to the benefit of and is binding upon the parties and the respective heirs, administrators, executors, successors and assigns.
- 36. This Agreement will be governed by and construed in accordant with the laws of the Province of Alberta.
